Many of my constituents, to their detriment, end up going without their medicine so they can afford their rent, or put food on the table. It is a sad truth the County of San Diego has been working to address.

In our County, particularly over the last three years, we have made significant investments to keep San Diegans housed and put food in their bellies, but your plan to lower prescription drug costs will give San Diegans and all Americans, the financial cushion they need in their bank accounts to buy their medicine, and still be able to fix the engine in the car they use to get to work, and maintain the home where they to raise their family.

Your leadership and policies to reduce prescription drug prices, lower healthcare costs and make tax-payer-funded medications more readily available is what Americans need right now. The relief you are working to provide to the people of San Diego County, and the entire United States, will change the lives of many, and save the lives of many more.
