# Majorities have a pessimistic view of California and San Diego County.



# Voters rate the County's Fire Department highly and most approve of the County's Public Health Services, but half disapprove of County government's job performance.



Would you say that San Diego County government has a great need for reforms, some need, a little need, or no real need for reforms?





# Eight in ten vote in favor of a Charter Amendment measure to make significant changes to County government, including half who say they would vote “definitely yes” if the election were held today.


**SAN DIEGO COUNTY GOVERNMENT REFORM, PUBLIC DISCLOSURE, ETHICS AND ACCOUNTABILITY CHARTER AMENDMENT MEASURE.** Shall the San Diego County Charter be amended to increase public disclosure/government transparency; create an independent Ethics Commission to investigate misconduct; require an elected County Executive; require an independent budget office and auditor; require that a nonpartisan legislative analyst review proposed County policies; require Board approval for County department heads; limit the County Executive and Board of Supervisor members to three, four-year terms; and require no new cost to taxpayers to implement?



*Initial Vote by Gender & Party*






# Regardless of race or ethnicity, eight in ten San Diego County voters would vote in favor of the Charter Amendment measure.

*Initial Vote by Supervisorial District*



*Please describe why would you vote YES on this measure?*









# Educational Statements

## Ranked by Percentage Saying Statement is a **VERY Convincing** Reason to Vote Yes

**(OUTDATED)** The San Diego County Charter is outdated, having not been updated in decades even as the county's population has grown to 3.3 million residents, compared to less than one million in 1980. Long-overdue changes are necessary to deliver better services, make county officials more accountable and responsive to voters, and impose stricter ethics laws to expose corruption, fraud and wasteful spending.

**^ (ELECTED CEX)** Voters, not politicians, should have the authority to select the County's top official who is responsible for managing our \$8 billion budget. Under the current system, an unelected bureaucrat holds the highest position in County government. This Charter Amendment will empower voters by requiring an elected County Executive who is directly accountable to voters, who have the power to vote them out of office.

**^ (SPECIAL INTERESTS)** There is too much corruption in County government with special interests and lobbyists using their power and money to rig the system. This Charter Amendment increases public disclosure and transparency so County politicians can't make secret deals behind closed doors, and it restricts lobbying and imposes tougher penalties on politicians and officials charged with corruption.

**^ (ETHICS)** San Diego County government lacks accountability as there is no independent oversight of County officials. This Charter Amendment creates an independent Ethics Commission to investigate allegations of misconduct, hold County officials accountable for corruption and expose public officials who abuse their power.



49%	<b>(APPOINTMENTS)</b> This Charter Amendment requires County department heads to be nominated by the County Executive and approved by the Board of Supervisors, and mandates these executive-level appointees have experience and expertise. For example, the head of the County Health Department must have a background in medicine and healthcare, and the independent auditor must have experience in accounting.
45%	<b>^(NO ADDITIONAL COSTS)</b> County officials are required to use existing funds to implement the reforms and changes mandated by this Charter Amendment. By law, County politicians and bureaucrats are prohibited from raising taxes or additional taxpayer money to make these changes.
45%	<b>(AUDITOR)</b> Under current County law, the Independent Auditor reports to an unelected bureaucrat rather than elected representatives. Requiring this position to report directly to the Board of Supervisors will increase accountability by promoting public disclosure and public access to audits of County spending, and investigations into fraud and misconduct
37%	<b>(CZAR)</b> From reducing homelessness to protecting local water resources from Tijuana River sewage, San Diego County has not been able to address major problems. This Charter Amendment reform measure will allow the Board of Supervisors to make special appointments – empowering a single individual to develop coherent strategies, coordinate resources, and implement solutions – and who can be held directly accountable.




# Eight in ten continue to vote in favor of the proposed County Charter Amendment after the educational statements.





# Half regard an argument against the Charter Amendment as a convincing reason to vote no...

Please consider the following statement from **opponents** of this Charter Amendment measure: The politicians who wrote this measure are trying to trick voters into believing it will reform County government and increase transparency. In fact, it gives them more power to control department heads, appoint their allies to a toothless ethics commission and weakens term limit laws. Passing this measure will do nothing to address the issues that matter most: the rising cost of living, a lack of affordable housing and homelessness; toxic sewage contaminating local water resources; politicians wasting money; and too much crime and gun violence in our communities.

# Conclusions

# Conclusions

- Eight in ten San Diego County voters think County government needs “major” or “some” reforms, and a similar proportion vote in favor of a proposed County Charter Amendment.
- Notably, there is a great deal of support for reforming County government, and it is consistent across all major demographic groups – in fact, regardless of party affiliation, eight in ten would vote yes to approve the proposed County Charter Amendment.
- There is widespread support for a number of potential changes to County government, in particular voters have very positive reactions to requiring greater public disclosure of County spending, limiting lobbying by former County officials, creating an independent ethics commission, and requiring the measure be implemented with no cost to taxpayers.
- The survey also shows that information about the County Charter resonates strongly with voters – this includes how long it has been since it was updated, the inability of elected officials and voters to hold county employees accountable, and the lack of a nonpartisan budget office or auditor.
- In sum, these results suggest San Diego County voters embrace the idea of implementing major reforms to County government and would be likely to vote in favor of a Charter Amendment measure if one were to be placed on the ballot in an upcoming election.
