7	Partnership For a Better San Diego	<p>The mission of the Partnership for a Better San Diego is to combat food insecurity and promote economic stability in San Diego and Imperial Counties by empowering underserved populations.</p> <p>Funds will be used to support the costs of the food pantry with the purchase of food, office supplies including cards, tables and canopies, gas, and vehicle supplies.</p> <p>Funds are in the public interest as the food pantry provides nutritious food for community members in need.</p>	\$20,000
8	San Diego Children's Choir	<p>The mission of the San Diego Children's Choir is to provide musical experiences to youth that build confidence, creativity, and community.</p> <p>Funds will support the purchase of laptops, music workbooks, portable rugs and branded bags.</p>	\$10,000

9	San Diego County Bar Association	<p>The mission of San Diego County Bar Association is to connect lawyers and support their success and fulfillment.</p> <p>Funds will be used to support sound proofing for the new SDCBA office located at 330 A St, San Diego, CA 92101.</p> <p>Funds are in the public interest as this sound proofing will increase confidentiality in attorney-client communications and provide a safe space for the community to have meetings.</p>	\$5,446
10	San Diego Youth Symphony and Conservatory	<p>The mission of the San Diego Youth Symphony and Conservatory is to make music a vehicle for giving youth the social, emotional, and interdisciplinary skills that prepare them for life.</p> <p>Funds will support the CHIMES and Music Discovery programs with the costs of sound equipment, musical teaching tools and instruments, branded materials including shirts, promotional items, and giveaways.</p> <p>Funds are in the public interest as these programs provide “cradle through college” programs for music education and interdisciplinary skills for youth.</p>	\$5,000
